YOUNG CONSERVATIVES OF TEXAS RATES THE 73RD TEXAS LEGISLATURE

Young Conservatives of Texas has selected the following bills which it believes accurately serve to gauge a legislator's philosophy in light of YCT's Statement of Principles.

In the ratings a "+" indicates the legislator voted FOR the conservative position as determined by YCT; a "-" indicates the legislator voted AGAINST the conservative position. A "P" indicates the legislator was present but did not vote; an "E" indicates an excused absence. No penalties were assigned for these actions. Non-excused absences were signified by an "A" and are counted as half a positive score.

There are two numerical scores shown on the ratings. The first score represents the legislator's performance during the 73rd Texas Legislature. The second score is a composite rating, based on the member's votes in all previous sessions. (YCT has rated each session since 1975.) As these ratings are based on a 0-100 liberal to conservative continuum, the higher a legislator's rating, the greater the lawmaker's commitment to conservative principles.

** represents a perfect score of 100%. Italics identify *Republicans*. Democrats are in regular type. Speaker Laney is not rated for the 73rd session. Therefore, his composite score is composed of ratings from past sessions.

Representative Bill Blackwood's absences during the 73rd session were due to a terminal illness.

** Shortly after the session ended, Rep. Nieto and Rep. Williamson switched parties to become Republicans and Rep. Erickson switched to become a Democrat.

House Vote Explanations

1. HJR 23. Proposes a constitutional amendment permitting the denial of bail to certain persons charged with certain violent or sexual offenses. (adopted 126-16). YCT-Yes. Persons charged with vicious and heinous crimes should not be allowed to go free on bail while awaiting trial. (RV 199, April 20, 1993)

2. Adoption of the Schechter-Kamel Amendment to CSSJR 14. The Schechter-Kamel Amendment provides that persons may not serve continuously for more than 12 years as members of the Texas Legislature. (adopted 76-61). YCT-Yes on adoption. Elected officials should serve as public servants, not as career politicians. Term limits should also reduce legislators' retirement pension costs paid by taxpayers. (RV 516, May 25, 1993)

3. CSSJR 9. Proposes a constitutional amendment providing for the issuance of \$50 million in general obligation bonds for the state financing if start-up costs of "historically under-utilized" businesses (HUBs), the new politically correct term for minority businesses. (passed 89-40). YCT-No. The free-enterprise system provides unlimited opportunities for minority entrepreneurs to start their own businesses. The state has no business subsidizing businesses on the basis of gender or ethnic origin. (RV 521, May 25, 1993)

4. Passage of Chisum Amendment to SB 1067. The Chisum Amendment would have made Texas' sodomy law applicable to deviant sexual intercourse between heterosexuals and homosexuals. The Chisum Amendment was designed to help preserve Texas' current sodomy law which is under challenge by militant homosexual activists. The Senate earlier voted to legalize sodomy. (adopted 75-48). YCT-Yes on adoption. The passage of the Chisum Amendment was crucial in retaining sodomy as a criminal offense. Individual freedoms must be balanced with a respect for traditional moral values based on religious beliefs. (RV 330, May 6, 1993)

5. HB 740. Requires that only licensed master plumbers or journeyman plumbers may install medical gas piping after passing an examination. (passed 83-55). YCT-No. Unnecessary state regulation tailored to benefit a special interest group. (RV 146, April 6, 1993)

6. HJR 54. Allows garnishment of wages for court-ordered payments in a criminal judgement. (adopted 121-22) YCT-Yes. This proposed constitutional amendment provides a more effective means to assure that criminals pay for their actions. (RV 411, May 13, 1993)

7. Motion to table the Craddick Amendment to SB 5 (General Appropriations Bill). Motion to table Craddick Amendment that would freeze the number of state employees in all state agencies

except the Texas Department of Criminal Justice and MHMR in fiscal years 1994 and 1995. (tabled 77-68). YCT-No on the motion to table. Freezing the number of state employees is necessary to control the spiralling growth in the state bureaucracy and to save taxpayers money. (RV 165, April 14, 1993)

8. Adoption of the Chisum Amendment to HB 1062. The Chisum Amendment would have required a 24-hour waiting period for women seeking abortions and would have required doctors performing abortions to provide information to help women decide whether or not to have an abortion. (failed 68-71). YCT-Yes on the amendment. Women should be fully aware of what an abortion involves and the positive alternative to abortion: bringing human life into this world. (RV 426, May 17, 1993)

9. Motion to table Grusendorf Amendment to SB 7. The Grusendorf Amendment to SB 7 would have created a program to test the effectiveness of a voucher system for low-income students attending public and private schools. (motion to table lost 70-70). YCT-No on the motion to table. A voucher system places control over our children's education where it should be--with the parents. The resulting competition between public and private schools would improve the quality and efficiency of education for all children. (RV 457, May 20, 1993)

10. HB 1873. Provides that new state workers hired after August 31, 1993, would have to pay half of their Social Security taxes. (passed 79-54). YCT-Yes. Currently the state pays both the employer's and as much as \$965.25 of each state employee's share of Social Security taxes. This measure, if it had not been vetoed by Governor Richards, would have saved \$25 million in the years 1994-1995, according to the state comptroller. (RV 346, May 7, 1993)

11. HB 415. Provides that litigation concerning certain misrepresentations on the sale or purchase of securities must be brought under the Texas Securities Act, not the Deceptive Trade Practices Act (DTPA). (passed 80-51) YCT-Yes. Reduces excessive and costly securities litigation. Eliminates inharmonious inconsistencies in state law that result in litigants in securities cases suing for punitive or treble damages under the DTPA instead of for actual damages and reasonable attorney fees under the Texas Securities Act. (RV 94, March 15, 1993)

12. Motion to table the Maxey Amendment to SB 963. The Maxey Amendment would have deleted a provision allowing local governments to contract with private waste management firms for collecting and disposing solid wastes. (tabled 83-44). YCT-Yes on the motion to table. Contracting with private

waste management firms would save taxpayers money and provide more efficient and environmentally-sound solid waste collection and disposal systems. (RV 495, May 24, 1993)

13. Adoption of the Grusendorf Amendment to HB 27. The Grusendorf Amendment provides capital murder penalties for murders caused as a result of drive-by shootings. (passed 82-57). YCT-Yes on Grusendorf Amendment. Capital murder offenses punishable by death are necessary to curb murders caused as a result of drive-by shootings from vehicles. Drive-by shootings have sharply increased in Texas and have been related to gang activity. (RV 194, April 19, 1993)

14. HB 783. Extends the life of the Automobile Theft Prevention Authority by two years, from November 30, 1995 to August 31, 1997. (passed 85-52). YCT -No. The Department of Public Safety spends \$4 million annually to reduce auto theft. This is inefficient government duplication. (RV 73, March 3, 1993)

15. Motion to table the Dutton Amendment to SB 532. The Dutton Amendment provided that the commissioners court of a county may appoint a jail administrator to run county jails. (tabled 85-44). YCT-Yes on motion to table. Unnecessary government duplication between the powers of elected county sheriffs and jail administrators. The amendment would have complicated local law enforcement efforts and added another level of bureaucracy. (RV 327, May 6, 1993)

16. HB 1776. Provides licenses for law-abiding citizens to carry concealed handguns. Applicants must have no criminal record and take gun safety courses. (passed 95-47). YCT-Yes. Provides law-abiding citizens an important means of protecting themselves against violent crime. (RV 248, April 26, 1993)

17. HJR 36. Proposes a constitutional amendment to cap the tax rate imposed on a corporation's income at 4.5 percent. (adopted 108-37) YCT-Yes. Limiting taxes on corporations is necessary for job creation and economic growth. (RV 393, May 11, 1993)

18. Motion to table the Swinford Amendment to CSSB 7. The Swinford Amendment provided for net revenues from the operation of the state lottery to be allotted to finance public education. (tabled 70-68). YCT-No on motion to table. Monies for "equalizing" public school finances should come from voluntary revenue sources such as the state lottery and not from increasing taxes of redistributing property tax money from wealthier school districts. (RV 196, April 19, 1993)

19. HB 2602. Provides that courts would now have the option on whether or not to award twice the amount of actual damages in cases relating to consumer protection for competition and unfair practices in the businesses of insurance. (passed 69-67) YCT-Yes. Present law provides that courts must award damages at twice the amount of actual damages in insurance consumer protection litigation. This bill would help to reduce excessive punitive awards by allowing the courts to award an amount less than the required twice the amount of actual damages. (RV 204, April, 20, 1993)

20. Motion to table the Culberson Amendment to SJR 7. The Culberson Amendment would have restricted the authority of the Texas courts to intervene in public education financing, and enhanced the Texas Legislature's flexibility in determining the funding of public schools. (tabled 79-68). YCT-No on the motion to table. Our elected representatives, and not the courts, should decide our public education policy. (RV 20, February 9, 1993)

21. Motion to table the Gallego Amendment to SB 2. The Gallego Amendment provides that state courts must exercise jurisdiction on lawsuits for damages sustained in foreign countries through the use of pesticides made and sold in Texas. (tabled 93-46). YCT-Yes on the motion to table. Foreign courts, not the state of Texas, are the proper forum to bring strict liability lawsuits for damages that occurred outside the U.S. State courts should have the discretion to decide whether to exercise long-arm jurisdiction in such cases. (RV 56, February 22, 1993)

22. Motion to table the Ogden Amendment to SB 1. The Ogden Amendment would have required a person who was convicted of driving while intoxicated and whose drivers license had been suspended to attend counselling and rehabilitative services for alcohol dependence as a condition for the person to be granted an occupational license to meet essential needs. (motion to table failed 66-75). YCT-No on motion to table. Drinking and driving is a serious offense that has killed or injured thousands of persons. Requiring persons convicted of a DWI to undergo counselling and rehabilitation would create a greater awareness of the severity of this crime and enhance public safety. (RV 428, May 18, 1993)

23. Adoption of the Duncan Amendment to the Counts Amendment to HB 1461. The Duncan Amendment allows insurance companies to provide premium and loss information to the State Board of Insurance for input in setting insurance rates. (adopted 68-58). YCT-Yes on adoption. Insurance companies should be allowed to provide information to the Board of Insurance to preserve the solvency of the state's insurance industry. (RV 351, May 7, 1993)

24. Motion to table the Craddick Amendment to SB 7. The Craddick Amendment provides that school districts may not increase property tax rates unless the taxes are approved by a majority of voters at an election held for that purpose. The amendment would not apply to a tax increase necessary to maintain the district's current level of local revenue per student. (tabled 78-61). YCT-No on the motion to table. Taxpayers should have input on whether property tax increases are necessary or whether the school district should spend tax dollars efficiently and trim unnecessary costs. (RV 460, May 20, 1993)

25. Motion to table the Culberson Amendment to HB 1116. The Culberson Amendment provided that the attorney general should appeal to federal courts and request that the Texas Department of Criminal Justice be allowed to 1). increase capacity of prison system to maximum levels using procedures established by state law and 2). house inmates in tents or temporary housing. (tabled 86-53). YCT- No on the motion to table. The attorney general and the State of Texas should pursue all legal avenues to regain the right to run our prisons at maximum capacity and to obtain flexibility in the ways the state manages its prison system. The solution is to house prisoners at lower costs to the taxpayers and, at the same time, to avoid letting dangerous criminals be released early. (RV 108, March 23, 1993)
